## SUBJECT: RESOLUTIONS ADOPTED AT THE AGM ON 28<sup>TH</sup> MARCH 2025

#### Introduction:

On behalf of the BOD and Management of UPRS, we write to express our gratitude to all members who participated in the successful Annual General Meeting (AGM) held on the 28th of March 2025 at the UBFC Auditorium.

The engagement was participative, and members were keen on resolving key issues that will shape UPRS's growth. Members embraced digitization, transparency, change in the operation model, transition in governance, among others. Below, we present to you the resolutions that were made and adopted and the actions required to turn them into reality.

#### The Resolutions

- Updating Membership Registries and Metadata: It was resolved that all members update their metadata.
  This is intended to complete the database, which will facilitate the distribution exercise and enhance the
  efficiency of our new monitoring system.
- 2. **Split sheets:** We adopted this initiative to ensure representation and fair royalty distribution across the value chain, including; performers, producers, publishers and writers.
- 3. **Membership Registration Fee:** A one-time registration fee of 50,000 UGX was adopted immediately for the registered members to obtain IPIs (Interested Party Information codes) and WID (Works Information Database codes among other benefits.
- 4. **Establishment of a Benevolent Fund:** The AGM tasked the Board to find ways of how to capitalize the Benevolent fund in support of members' welfare.
- 5. **Enhancing Visibility and Membership Growth:** Members approved regional campaigns to attract more rights holders and strengthen the Organization across the Border.
- 6. **Special Purpose Vehicle:** It was resolved that a model be developed in support of implementing the project.

## **Action Required**

- 1. Members are required to update their registration with complete metadata within 2 months from the date of the Annual General Meeting (AGM). **Timeline**: May 31, 2024.
- 2. Members are requested to pay UGX. 50,000 (Fifty Thousand shillings) as a registration fee to maintain their membership status.
